**Ground 2 Skye PRIVY (off Southern Avenue):** This is a high-rise residential building with 18 floors located at S P Mukherjee Road, Tollygunge, South Kolkata. The building is ultra-luxurious and offers a wide range of amenities and facilities to the residents. It overlooks the famous Rabindra Sarobar Lakes and is located in a prime area of the city. The building offers a range of spacious and well-designed apartments with modern fittings and fixtures.

**Ground 2 Skye Town Square (Barrackpore):** This is a mixed-use building that would offer both residential and commercial spaces. It is located at a prime location in Barrackpore and aims at providing a range of modern amenities to the residents. The commercial spaces cater to the needs of the residents and the local community, while the residential units offer comfortable and modern living spaces.



**Extension of B.P Poddar Hospital:** This project involved the project management consultancy work for extending one of the premium hospitals in Kolkata, B.P Poddar Hospital. # UPCOMING PROJECTS

**1. B+G+20 floors commercial tower in Chowringhee** spanning approximately 150,000 sq. ft.: This upcoming project is a large-scale commercial tower that will span an area of approximately 150,000 sq. ft. The tower will have 20 floors plus a ground floor and will be located in Chowringhee, one of the most vibrant business districts of Kolkata. The tower is expected to provide state-of-the-art facilities and amenities to the tenants, including ample parking, highspeed elevators and advanced surveillance systems.

**2. B+G+12 floors of mixed-use building at Pathuriaghat, Burra Bazar, Kolkata,** that will have commercial space up to the 3rd. floor and residential units on the upper floors. The saleable area of the tower would be in excess of 120,000 sq. ft. This would turn out to be one of the most prestigious projects awarded to the Group and would help to significantly transform the congested business district and the skyline of Burra Bazar.

**3. B+G+4 commercial-cum-residential building of 17,000 sq. ft. at Topsia Road:** This upcoming project is a mixed-use building that will have commercial space on the ground floor and residential units on the upper floors. The building is located in an up-and-coming neighborhood in Kolkata and is expected to be a modern and stylish addition to the area. The commercial space on the ground floor will cater to the needs of the residents, while the residential units will provide comfortable and contemporary living spaces.

**4. G+4 residential Cooperative building in New Town:** This upcoming project is a cooperativeresidential building of around 12,000 sq. ft. with 4 floors plus a ground floor, located in NewTown, Kolkata. The building will provide modern and comfortable living spaces to the residents. The design of the building will aim to provide maximum natural light and ventilation to the living spaces.

**6. The building will span an area of approximately 7,000 sq. ft. and will provide modern and comfortable living spaces to the residents. The building's design will aim to provide ample natural light and ventilation to the living spaces, while the amenities will include a gym and a community hall.
